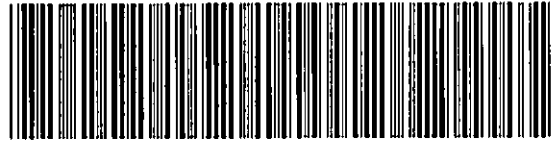

ARTICLE III – Amendment


