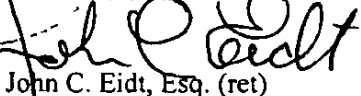
This is to advise that I am trying to assist the General Manager of the above captioned Limited Liability Company, Charles J. Villella, in restoring the status of the corporation.

The corporation was formed on 3-1-07 but he recently discovered that the company was about to be administratively dissolved because of not filing an annual report (2008) or to pay the required annual fee. He states that he is willing to submit an affidavit that he has been at the company address, P.O. Box 349, Cassadaga, Florida 32724 continuously since filing the Articles, and he has not received the notices for filing the annual report or any notices until the present notice was received.

Accordingly, he is willing to pay the annual report fees for the 2008 annual report but feel it would be unfair to be penalized for not filing when he did not receive notice that the reports were due. As this was a new corporation and the General Manager were not accustomed to the annual report filing procedures, his request is a reasonable one.
