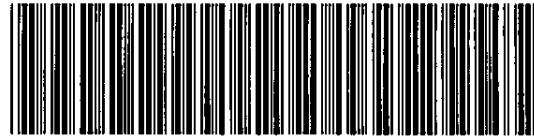

**ARTICLES OF ORGANIZATION  
OF  
MORNING GLORY RANCH, LLC**

These Articles of Organization of Morning Glory Ranch, LLC are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**Article 1 – Name**

The name of this limited liability company is Morning Glory Ranch, LLC ("Company").

**Article 2 – Purpose**

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

### **Article 7 – Termination of Membership**

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to the Company's Operating Agreement.

### **Article 8 – Operating Agreement**

The Members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

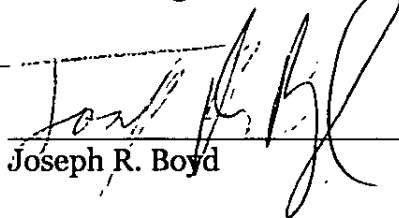
