ARTICLES OF ORGANIZATION

OF

CAMDEN CROSSING I MANAGERS, L.L.C.

In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended.
