**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
VALUE INCOME PROPERTIES, LLC  
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, **VALUE INCOME PROPERTIES, LLC**, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

- FIRST:** The Articles of Organization of the Company were filed on March 1, 2007, and assigned document number 1.07000023209.
