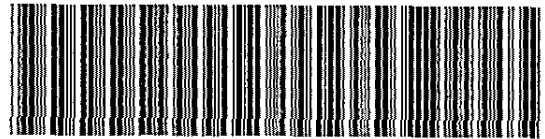

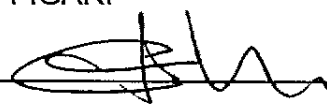
ARTICLE V. EFFECTIVE DATE & DURATION
