**ARTICLES OF ORGANIZATION
OF
MARLIN, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned (the "Member") acting as the organizer of **MARLIN, LLC**, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is:

PURPOSE AND POWERS**

The Company shall be managed by one or more managers as provided in the Company's Operating Agreement.
