ARTICLES OF ORGANIZATION**OF****DR. SANDRA BALLESTER, PROFESSIONAL LIMITED COMPANY**

The undersigned, who is a duly licensed psychologist in the State of Florida, desiring to form a limited liability company in accordance with Chapter 608 of the Florida Statutes and the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, adopts the following Articles of Organization:

ARTICLE I**Name**

The name of the limited liability company ("Company") is Dr. Sandra Ballester, Professional Limited Company.

ARTICLE II**Address**

The mailing address and street address of the Company's principal office is 20 Orange Avenue, Suite 600, Orlando, Florida 32801.

ARTICLE III**Duration**

The period of duration for the Company is perpetual.

ARTICLE IV**Purpose**

The professional services of the Company shall be rendered only through members, employees and agents who are duly licensed or otherwise legally authorized to practice psychology within the State of Florida. Professional services shall be rendered in each case by the member, employee or agent designated solely by this Company, acting through its managing member. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of the practice of psychology.

ARTICLE VI


