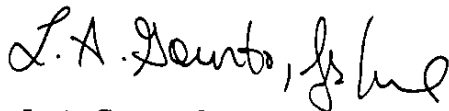

NAME

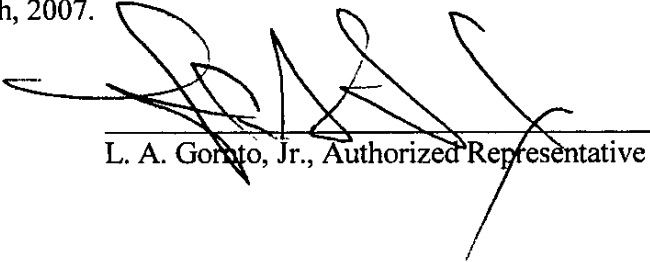

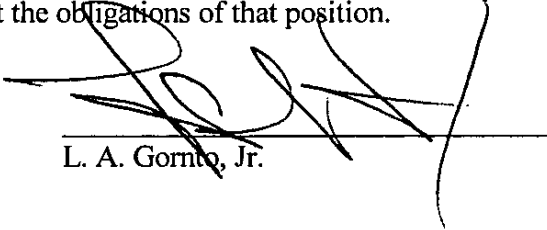
