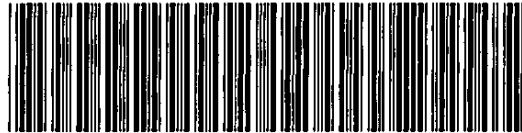

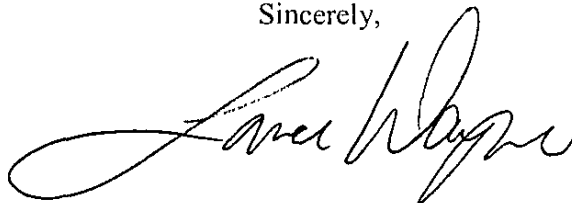

The principal place of business and mailing address of the Company shall be:

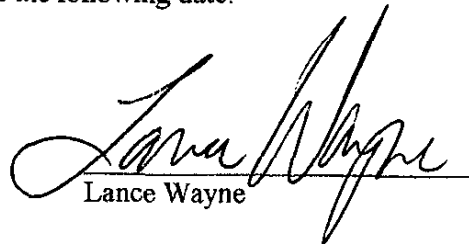

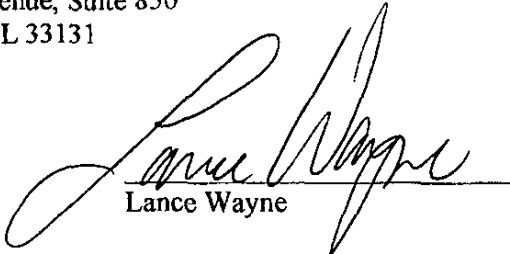

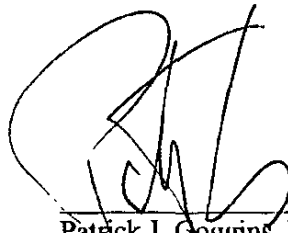
