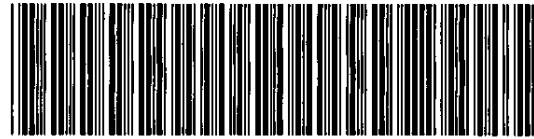

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **MCGEE MARKETING & INVESTMENTS LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 3628 Northwoods Drive, Kissimmee, Florida 34746 and the mailing address shall be P.O. Box 771834, Orlando, Florida 32877.

ARTICLE 3 - EFFECTIVE DATE


