ARTICLES OF ORGANIZATION
OF
BELVEDERE INVESTMENT PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Belvedere Investment Properties, LLC (the "Company"). The street address of the principal office of the Company in Florida shall be 1409 Kingsley Avenue, Building 2, Orange Park, Florida 32073, and the mailing address of the Company in Florida shall be P.O. Box 2426, Orange Park, Florida 32067.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE V**TERMINATION OF EXISTENCE**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

David J. Muyres and Robert J. van Winkel shall be the initial members of the Company.


ARTICLE VII**MANAGEMENT**


