## Articles of Organization OF Bluewater Reef Tanks, LLC Limited Liability Company

KNOW ALL MEN BY THESE PRESENTS: That I, Eric A Griesdorf, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. <u>Company Name</u>. That the name of the limited liability company is Bluewater Reef Tanks, Limited Liability Company.
- 2. <u>Duration</u>. That the period of duration of this limited liability company is thirty years from the date of filing hereof with the Florida, unless sooner dissolved as provided by Florida law.
