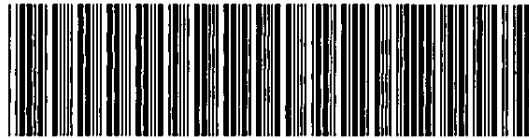



ARTICLE V
