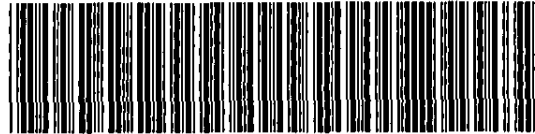


ARTICLES OF ORGANIZATION OF

The undersigned hereby makes, subscribes, and files these Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act

1. **Name.** The name of the limited liability company is **FULL MOON PIZZA, LLC.**
2. **Duration.** The period of duration of the limited liability company is perpetual.
3. **Principal Office.** The mailing address and the street address of the principal office of the limited liability company is: 407 Lincoln Road, Suite 300, Miami Beach, Florida 33139.

No Member shall be entitled to receive a return of capital or other distribution upon withdrawal from this limited liability company or otherwise, except as otherwise provided in the Regulations of this limited liability company.


