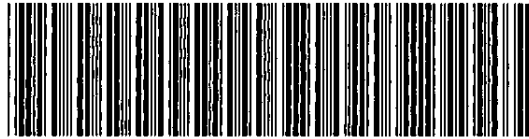

**ARTICLES OF ORGANIZATION  
OF  
VMRT INTERPRISE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I – NAME**

The name of the limited liability company shall be VMRT Interprise, LLC (the "**Company**").


**ARTICLE II – ADDRESS**

## ARTICLE VI – ADMISSION OF NEW MEMBERS

No member(s) shall or may be admitted to the Company except upon the unanimous written consent of all the members of the Company. A member may transfer his or her interest in the Company in any manner authorized by the regulations of the Company; provided, however, that the transferee shall have no ability or entitlement to exercise any rights or privileges attendant to membership in the Company or to participate in the management of the business and/or affairs of the Company, unless all members of the Company approve of the proposed transfer by unanimous prior written consent.

## ARTICLE VII – MANAGEMENT

The Company shall be managed by the member(s) in accordance with regulations adopted by the members for the management of the business and affairs of the Company. The regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
