

# ARTICLES OF ORGANIZATION

OT HR. G. H. B. HO The undersigned, for the purpose of forming a limited liability company under the Florical Company und Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

# ARTICLE I - NAME

The name of the limited liability company shall be Honacher Properties, LLC ("Company"),

# ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 232 Norman Street, Port Charlotte, Florida 33954.

### ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

# ARTICLE IV - REGISTERED OFFICE AND AGENT

# ARTICLE VII - ADMISSION OF NEW MEMBERS
