The Limited Liability Company is to be manager-managed. The names and addresses of the initial managers are:

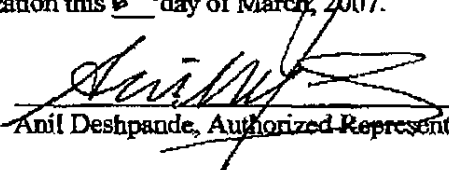
