**ARTICLES OF ORGANIZATION  
OF

Pursuant to section 608.407 of the Florida Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I  
NAME**

The name of the limited liability company (the "Company") is DAVID B. DUENSING AQUATIC CONSTRUCTION SERVICES, LLC.

**ARTICLE II  
DURATION**

Unless earlier terminated pursuant to the Act or the Operating Agreement of the Company, the period of its duration shall be perpetual.

**ARTICLE III

**ARTICLE VI  
CONTINUATION OF BUSINESS**

The remaining members of the Company may continue its business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member or the occurrence of

any other event which terminates the continued membership of the member or members in the Company as provided in the Act or the Operating Agreement of the Company.


**ARTICLE VII


