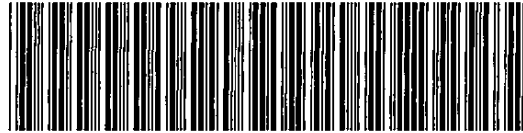

**ARTICLE I  
NAME**

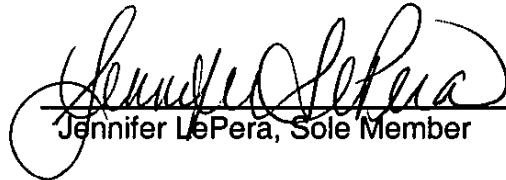

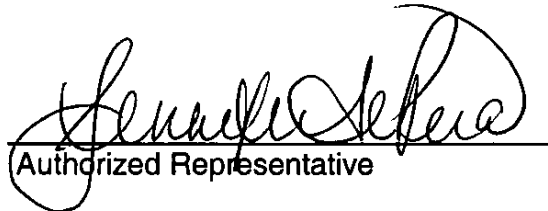
**CERTIFICATE OF DESIGNATION OF
