ARTICLES OF DISSOLUTION OF MOBILE AD TAILGATING LLC

SECOND: The date of the adoption of these Articles of Dissolution is 6 October 2008.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
