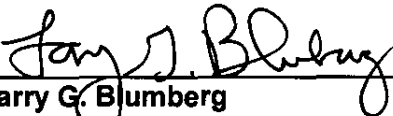
RESOLVED, it would be in the best interests of the Company and its members for the Company to be dissolved.
