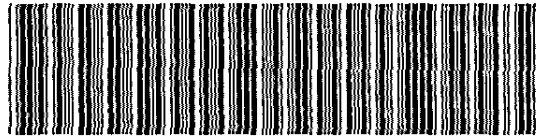


**ARTICLES OF ORGANIZATION

The undersigned as Organizer of a limited liability company having two or more members pursuant to the Florida Limited Liability Company Act adopts the following Articles of Organization.

- 1. Name.** The name of the limited liability company is **SCHWERER LANDSCAPING, LLC**.
- 2. Duration.** This limited liability company shall have perpetual existence from the date of filing of these Articles of Organization with the Department of State, unless sooner terminated as provided in the Operating Agreement.
- 3. Principal Place of Business.** The mailing address and its principal place of business is 2705 Placid Avenue, Fort Pierce, Florida 34982.
- 4. Registered Agent & Office.** The name of its registered agent, whose Consent to Appointment as Registered Agent accompanies these articles, is Robert V. Schwerer, Esquire, and the address of the registered office is 515-519 South Indian River Drive, Fort Pierce, FL 34950.
- 5. Management.** This limited liability company shall be managed by a member or its members and, therefore, is a member-managed company. The initial managing member is Michael P. - 7. Amendment of Articles.** These articles may be amended only by a unanimous vote of the members.


