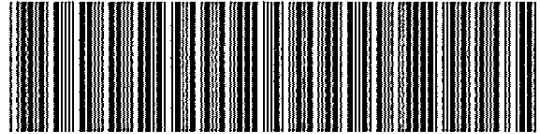

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **SYNERSTHETICS MEDICAL GROUP LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 495 South Nova Road, Suite 107, Ormond Beach, Florida 32174 and the mailing address shall be 2450 Tyne Terrace, Smyrna, Georgia 30080.

ARTICLE 3 - EFFECTIVE DATE
