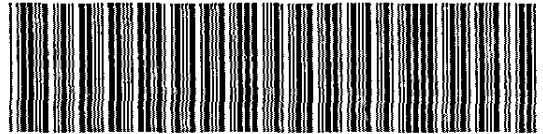

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **PREFERRED FINANCIAL ENTERPRISES, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2800 West Oakland Boulevard, Suite 207, Fort Lauderdale, Florida 33311 and the mailing address shall be 4158 Inverrary Drive, #410, Lauderhill, Florida 33319.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

whose addresses shall be the same as the principal office of the Company.



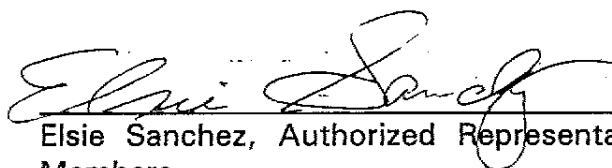

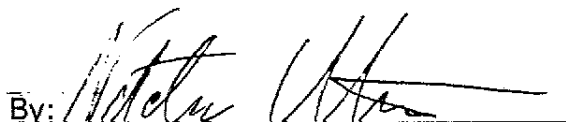
