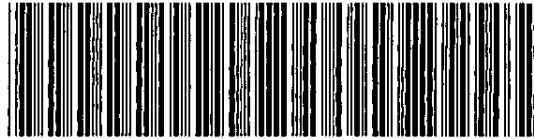



ARTICLE I—NAME

The name of the Limited Liability Company shall be: **BASY ENTERPRISES, LLC** (the "Company").


ARTICLE II—ADDRESS

ARTICLE V—EFFECTIVE DATE

In accordance with Section 608.409, Florida Statutes, the effective date of these Articles of Organization shall be 12:01 am on date when these articles are filed, as evidenced by the Department of State's date endorsement on the original document (the "Effective Date").

ARTICLE VI—DURATION

Except as otherwise provided by law or in the Company's Operating Agreement, if any, the period of the Company's duration is perpetual unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the Company is continued by the consent of all remaining members, or amendment of these Articles of Organization providing for the continued existence of the Company subsequent to the foregoing events.

ARTICLE VII—ADMISSION OF ADDITIONAL MEMBERS/RIGHT TO CONTINUE BUSINESS

Additional members may be admitted upon the unanimous approval of all members of the Company, upon receipt of the written application of such new member, and in the manner set forth in the Bylaws of the Company.

The remaining members may continue the business of the Company subsequent to the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company.

ARTICLE VIII—PURPOSE

The purpose of the Company shall be: (i) to render home services including, but not limited to, home cleaning, pool cleaning, lawn care and landscaping, house-sitting, general home maintenance; and (ii) subject to the provisions set forth in Chapter 608, Florida Statutes, conduct such other lawful business as provided therein.
