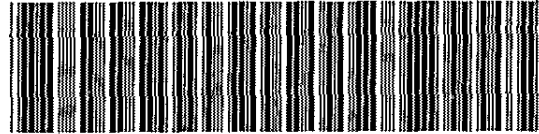



ARTICLE I – COMPANY NAME & ADDRESS


