ARTICLES OF ORGANIZATION

The undersigned authorized representative of a member, for the purpose of forming a limited liability company under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 and the Florida Limited Liability Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

ARTICLE I - NAME


ARTICLE III - PURPOSE
