**ARTICLE 1 - NAME**

The name of the limited liability company shall be Professional Valet Waste, LLC, (hereinafter, "Company").

#### ARTICLE 6 - PURPOSE

This Company shall be permitted to engage in any and lawful activities in the State of Florida.
