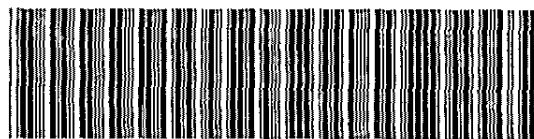

Business and Purposes


