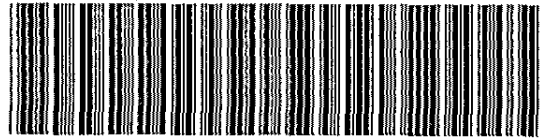

Business and Purposes




