

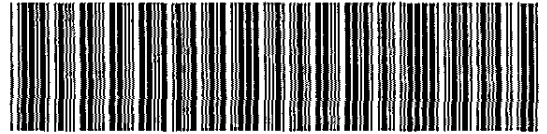

ARTICLES OF ORGANIZATION
OF
U-LUBE, LLC
a Florida limited liability company

The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, do hereby adopt the following Articles of Organization, and do hereby agree and certify as follows:

ARTICLE ONE
NAME

The name of this Limited Liability Company shall be U-LUBE, LLC (the "Company").

ARTICLE TWO
PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office, mailing address, and street address of the Company shall be located at 110 South Courtenay Parkway, Suite 2, Merritt Island, Florida 32952.
