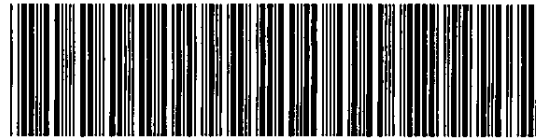

ARTICLE I - NAME

The name of the limited liability company is BEST CHOICE BILLING, LLC.

ARTICLE II - ADDRESS

The mailing and street address of the company is 6400 Jeff Ates Road, Milton, Florida 32583.

ARTICLE III - PURPOSE

The company has been organized for commercial development and any other lawful business.

ARTICLE IV - INITIAL MEMBERS

ARTICLE V - TRANSFER OF INTERESTS

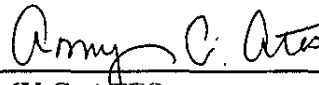
