### FIRST AMENDMENT TO ARTICLES OF ORGANIZATION OF

### SUNDANCE GRAPHICS, LLC

THIS FIRST AMENDMENT TO ARTICLES OF ORGANIZATION ("Amendment") is dated as of November (1), 2022 (the "Effective Date") by Sundance Graphics. LLC, a Florida limited liability company (2)

WHEREAS, Sundance Graphics, LLC, was organized under the Articles of Organization dated March 9, 2007; and

WHEREAS, the Sundance Graphics, LLC, hereby intends to amend the Articles of Organization on the terms and conditions set forth below.

NOW, THEREFORE, acknowledging the receipt of adequate consideration and intending to be legally bound, Audrey Ruggieri, as the managing member, hereby amends Sundance Graphics, LLC's Articles of Organization as follows:

## 1. <u>Modifications</u>.

In the event of any conflict between the Articles of Organization and this Amendment, the terms of this Amendment shall control.
- 3. <u>Counterparts</u>. This Amendment may be executed in two or more counterpart copies, each of which shall be deemed to be an original and all of which counterparts shall have the same force and effect as if the parties hereto had executed a single copy of this Amendment.
- 4. <u>Entire Agreement.</u> This Amendment and the Articles of Organization constitute the entire agreement between the parties hereto. In the event of a conflict between the terms and conditions of this Amendment and the Articles of Organization, the terms and conditions of this Amendment shall govern the respective rights and obligations of the parties hereto.
- 5. <u>Severability</u>. If any provision hereof shall be declared invalid by any court or in any administrative proceeding, the provisions of this Amendment shall be construed in such manner so as to preserve the validity hereof and the substance of the transaction herein contemplated to the extent possible.

- Effect on Articles of Organization. Except as otherwise modified hereby, all of the 6. terms, conditions and provisions of the Articles of Organization shall remain in full force and effect, and are hereby ratified and affirmed.
- Governing Law. This Amendment shall be governed by the laws of the State of 7. Florida.
