#### ARTICLES OF ORGANIZATION

## ON THE STATE OF TH INTEGRATED ISLAND CONSTRUCTION, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereBy makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company shall be INTEGRATED ISLAND CONSTRUCTION, LLC, ("Company").

#### ARTICLE 2 - ADDRESS
