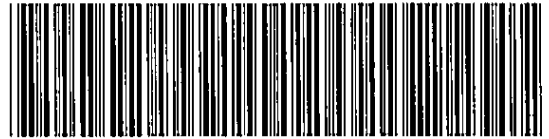

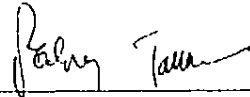
ASSIGNMENT OF MEMBERSHIP INTEREST

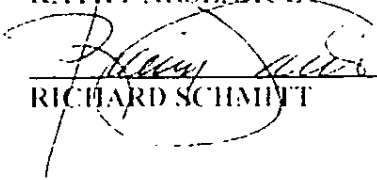

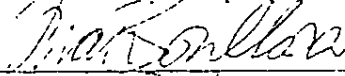
