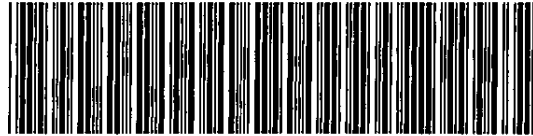



**ARTICLES OF ORGANIZATION**  
**OF**  
**PIT STOP SANITATION, L.L.C.**

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **PIT STOP SANITATION, L.L.C.**

**ARTICLE II - ADDRESS**

**THE MAILING ADDRESS** and street address of the principal office of the Limited Liability Company shall be 6204 Juel Gill Road, Myakka City, Florida 34251.

**ARTICLE III - DURATION**

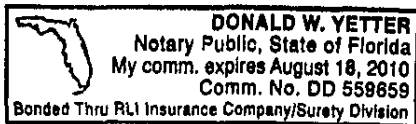
