**ARTICLES OF ORGANIZATION  
OF  
STEINBERG MANAGEMENT, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Steinberg Management, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 12749 Bay Plantation Drive, Jacksonville, Florida 32223.

**ARTICLE II**

**PURPOSES AND POWERS**

## ARTICLE VI

### MANAGER




