**ARTICLES OF ORGANIZATION
OF
CY VENTURES, LLC.**

The undersigned organizer, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (the "Act"), does hereby make, acknowledge and file the following Articles of Organization:

Article I
Name

The name of the limited liability company shall be **CY VENTURES, LLC.**, (the "Company").

Article II
Duration

The Company shall commence its existence on the date these Articles of Organization are filed with the Secretary of State. The Company's existence shall be perpetual.

Article III
Purposes and Powers

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida, and the Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

Article IV
Registered Office and Agent

No additional members shall be admitted to the Company except with the written consent of Two-Thirds Vote of the members of the Company and upon such terms and conditions as shall be determined by a majority of the members.

Article VII
Termination of Existence

The Company shall be dissolved upon the greater of a Member Majority Vote.

Article VIII
Management

The Company shall be managed by its members, who shall be entitled to vote in person or by proxy, in accordance with the Operating Agreement adopted by the members, which may contain provisions not inconsistent with the laws of this state or these Articles. Each member shall have a number of votes (including fractions) equal to such member's Units in the Company, with the total number of votes of all members totaling One Hundred (100).
