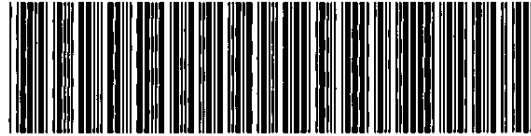


ARTICLE V


