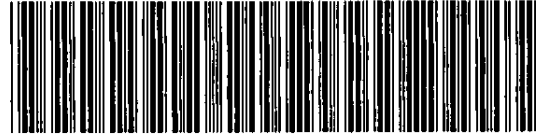

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

FIRST: The name and address of this Company is **C.J.C ENTERPRISE GROUP, LLC**, 1355 N. San Mateo Drive, North Port, Florida 34288.

SECOND: The date of the adoption of these Articles of Dissolution is 6 April 2009.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
