ARTICLES OF ORGANIZATION FOR A FLORIDA LIMITED
LIABILITY COMPANY

ARTICLE I - Name:

The name of the Limited Liability Company is Orange Blue, LLC

ARTICLE II - Address:

The mailing address and street address of the principal office of the Limited Liability Company is 4471 Grassy Point Blvd., Port Charlotte, Florida 33952-9181. The initial registered agent and address of such agent for the Limited Liability Company is James E. Moore, III, 1107 West Marion Avenue, Suite 112, Punta Gorda, Florida 33950.

ARTICLE III - Duration:

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

ARTICLE IV - Management:


