ARTICLES OF ORGANIZATION OF HUMAN PERFORMANCE, L.L.C.

ARTICLE I Name and Principal Place of Business

The name of this limited liability company is HUMAN PERFORMANCE, L.L.C.; the physical address of its principal office is 3322 Spy Tower Court, Valrico, Hillsborough County, Florida 33594, and its mailing address is the same.
