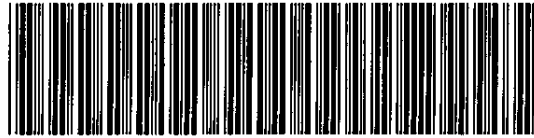

The mailing address and street address of the principal office of the company shall be 16 Castle Court, Fort Pierce, Florida 34949.

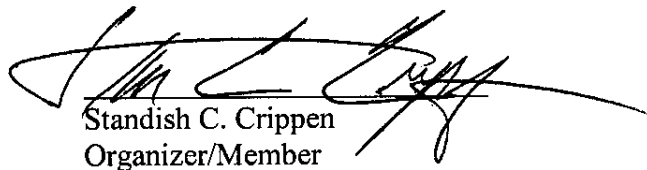
ARTICLE III-REGISTERED OFFICE AND AGENT

The company shall be a manager-managed company.

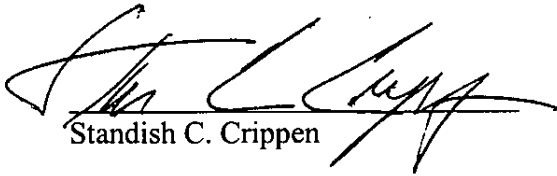
