

ARTICLES OF ORGANIZATION FOR
PROFESSIONAL SERVICE LIMITED LIABILITY COMPANY

ARTICLE III — AREA OF PRACTICE


The area of practice of the Limited Liability Company is limited to Veterinarian Medicine.


