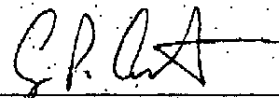
1. **Article I** is hereby deleted in its entirety and a new **Article I** shall replace any existing provision of the Articles of Organization. **Article I** shall read as follows:
