

#### ARTICLES OF ORGANIZATION

#### FOR

# YOUNG GUNS ROOFING, LLC

THE UNDERSIGNED MEMBER hereby adopts the following Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability

#### <u>ARTICLE I</u>

## Company Name and Principal Office

1.1 The name of the limited liability company shall be YOUNG GUNS ROOFING, LLC (referred to herein as the "Company"), and the mailing and street address of the Company's principal office shall be located at 3830 Laurel Street, St. Augustine, FL 32084. However, the members shall have the power and authority to establish branch offices at any other place or places as they may so designate.

#### ARTICLE II

### Management

- 2.1 This Company shall be managed by one (1) manager initially. However, the number of managers may be increased or diminished from time to time by unanimous vote of the members.
  - 2.2 The designated Manager shall have full authority to transact all business on the

Company's behalf including, without limitation, the following specific duties and authority:

- (a) <u>Nogotiate and Agree to Contracts</u>. The Manager shall have full authority to negotiate and agree to any terms necessary to purchase, acquire, lease, encumber, mortgage, sell or convey specifically designated Company property, or any possession, interest, or right therein, including personal property located thereon, upon such terms as the Manager shall think proper; and
- have full authority to make, endorse, accept, receive, sign, seal, execute, acknowledge and deliver any and all contracts, deeds, assignments, agreements, mortgages, security agreements, pledge agreements, certificates, hypothecations, affidavits, checks, notes, closing documents, bonds, vouchers, receipts and/or such other instruments in writing, of whatsoever kind and nature as may be necessary or proper with reference to the purchase, acquisition, lease, encumbrance, mortgage, sale or conveyance of Company property; and
- (c) Accept and Direct Proceeds. The Manager shall have full authority to accept or direct distribution of the any and all proceeds from such sale, lease, mortgage of the conveyance of the designated Company property.
