ARTICLES OF ORGANIZATION

OF

BENEFICIAL PINE BRANCH LLC

The undersigned acting as the organizer of BENEFICIAL PINE BRANCH LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopt the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is BENEFICIAL PINE BRANCH LLC (the "Company").

ARTICLE II - Address:

The mailing address and principal office address of the Company is 6455 Gateway Avenue, Suite A, Sarasota, Florida 34231.

ARTICLE III - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

ARTICLE IV - Management:

The Company shall admit new Members only upon the unanimous written consent of all the then existing Members of the Company.

ARTICLE VI - Adoption of Operating Agreement:

The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608, Fla. Stat.
