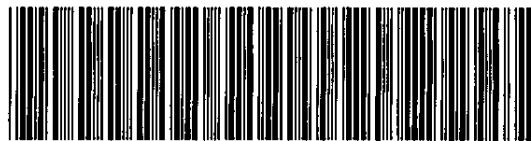

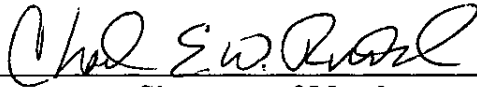

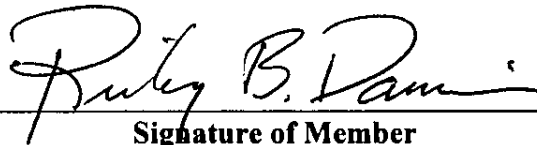
ARTICLE VI

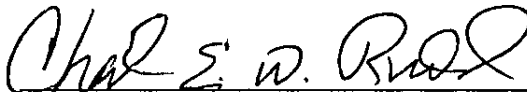
