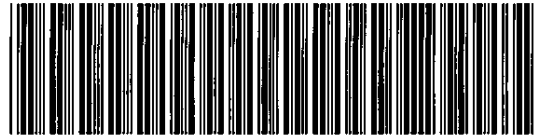

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I

ARTICLE II

Duration: The period of this limited liability company is perpetual, unless sooner dissolved.

ARTICLE III

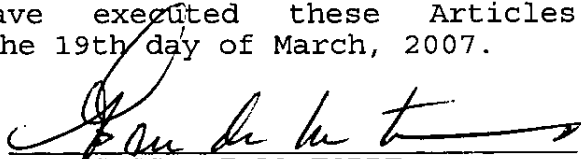
ARTICLE VIII

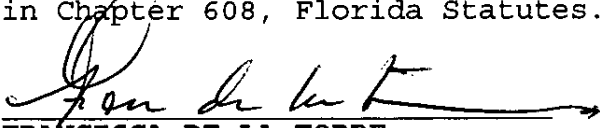
